normally between 2,000 and 10,000 words. **Format** when an article has been accepted for publication, the author is

> strongly encouraged to send a copy of the final version on computer disk (Apple Macintosh or IBM compatible p.c.) together with the hard copy typescript, giving details of the wordprocessing software used (Microsoft Word, Word or Word Perfect). However, the publisher reserves the right to typeset material by conventional means if an author's disk proves unsatisfactory. Manuscript to be typed in double-spacing on A4 or equivalent, one side only, with generous margins and consecutively numbered pages. Author's name should be given on a separate sheet (see Biographical note

below) to facilitate the anonymous refereeing process.

Abstract about 100 words; summarizing the contents of the article; should be

typed immediately below the title and above the main text. A note giving details of any acknowledgement should also be included.

Biographical of c. 75 words giving author's name, postal address, affiliation,

note principal publications, etc. should be submitted on a separate cover

Copies 2 copies of articles and one of reviews should be submitted and one
