
Notes on Contributors

Emile Chabal is a Chancellor's Fellow in History at the University of Edinburgh. He has worked on contemporary French political culture, Franco-British relations in the twentieth century, identity politics in the south of France and the intellectual history of French neo-liberalism. He is the author of *A Divided Republic: Nation, State and Citizenship in Contemporary France* (Cambridge, 2015) and editor of *France since the 1970s: History, Politics and Memory in an Age of Uncertainty* (Bloomsbury Academic, 2014). He has also published articles in *Geschichte und Gesellschaft*, *Contemporary European History* and *French Politics, Culture and Society*. He is currently working on an intellectual biography of Eric Hobsbawm in the context of post-war European intellectual life.

James Chappel is Assistant Professor of History at Duke University. He received his PhD in History from Columbia University in 2012, and he has also been a member of the Society of Fellows at the University of Chicago. He works on the intellectual, cultural and religious history of twentieth-century Europe. He is currently completing a book on Catholic social thought, Christian Democracy and European secularism from 1918 to 1968, which will be published by Harvard University Press. His work has appeared in, among other places, *Modern Intellectual History*, *Rethinking History* and *New German Critique*.

Pepijn Corduener is Assistant Professor in Political History at Utrecht University. He is mainly interested in the historical development of ideas and practices of democracy in modern Europe from a comparative perspective; as well as the legacy of fascism, the politics of nationalism and contemporary populism. He has published articles in, among others, the *Historical Journal*, *European Political Science* and the *Journal of War and Culture Studies*. His monograph *The Problem of Democracy in Postwar Europe. Political Actors and the Formation of the Postwar Model of Democracy in France, West Germany and Italy* was published by Routledge in 2016. He currently works on a project studying the integration of political parties with the state as a key feature of modern democracy.

Valerie Deacon is Visiting Scholar at New York University. Her work focuses on the Resistance in France and the diplomatic and personal relationships between the French, British, and Americans during the Second World War. She is the author of *The Extreme Right in the French Resistance: Members of the Cagoule and Corvignolles go to War, 1940–1944* (Louisiana State University Press, 2016) and ‘Fitting in to the French Resistance: Georges Loustaunau-Lacau and Marie-Madeleine Fourcade at the intersection of politics and gender’, *Journal of Contemporary History*, 50 (2015).

Daniel A. Gordon is Senior Lecturer in European History at Edge Hill University. He is currently working on a history from below of how passengers have interacted with public transport and state authorities in post-war France. His previous publications include *Immigrants and Intellectuals: May '68 and the Rise of Anti-Racism in France* (Merlin Press, 2012) and articles in journals such as *Vingtième Siècle*, *Migrations Société*, the *Journal of Contemporary History*, *Migrance*, *Contemporary European History*, *Modern and Contemporary France* and *Past and Present*.

Wim de Jong is a Dutch historian and political philosopher and Lecturer in political history at Radboud University Nijmegen, where he received his PhD in 2014. He specialises in the history of democracy, notably the connection between democracy and citizenship education. His PhD dissertation analysed contesting repertoires of democracy in the Netherlands between 1945 and 1985. In 2014 he held the Alexander Charters Fellowship at Syracuse University for research in adult education and in 2016 he was a visiting fellow at the Special Collections of Columbia University New York. His monograph on the history of protestant education in the Netherlands will appear in 2017. He is currently developing a research project on the history of philanthropy and its connection with consumer education and the social sciences.

Harm Kaal is a political historian and Assistant Professor at the History Department of Radboud University. His key areas of interest are the language of politics and urban planning, the scientisation of the political, the interaction between politics and popular culture and the history of electoral culture in the twentieth century. He has recently published in the *Journal of Urban History*, *European Review of History*, *Women's History* and the *Archiv für Sozialgeschichte*. Together with Stefan Couperus he has edited a volume in the Routledge Studies in Modern European History series: *(Re)Constructing Communities in Europe, 1918–1968. Senses of Belonging Below, Beyond and Within the Nation-State* (New York and London: Routledge, 2017).

Matthew Lewis has most recently worked as a Postdoctoral Fellow with the Centre for the History of Violence at the University of Newcastle, Australia. Until September 2013, he was an ERC Postdoctoral Fellow working on the project ‘The Limits of Demobilization’. His current research project is a comparative study of British paramilitarism in Ireland and Palestine after the First World War. His first book, *Frank Aiken's War: The Irish Revolution, 1916–23* (Dublin: UCD Press) was published in 2014 and explores the controversial revolutionary past of one of independent

Ireland's most prominent politicians and international statesmen and the broader context of republican politics and violence in the borderlands of south-east Ulster amid the upheavals of revolution, partition and civil war.

Kate Marsh is Professor of French Historical Studies at the University of Liverpool and a specialist in French colonial history. Her research focuses principally on French metropolitan representations of colonialism and on the rivalries and collusions between competing European colonial powers. She is the author of two monographs on the colonial relationship between France and India, *Fictions of 1947: Representations of Indian Decolonization 1919–62* (2007) and *India in the French Imagination: Peripheral Voices, 1754–1815* (2009), as well as a recent monograph on how the French empire was imagined in three literary representations of French colonialism, *Narratives of the French Empire: Fiction, Nostalgia, and Imperial Rivalries, 1784 to the Present* (2013). Her current project is a major re-examination of colonial encounters in French port cities during the interwar period.

Francisco Morente is Lecturer at the Universitat Autònoma de Barcelona. His main line of research lies in the ideological and cultural elements of Spanish fascism during the Spanish Second Republic, the Spanish Civil War and the early years of the Franco regime. He is the director of the research group Studies on Republic and Democracy, and the principal investigator of the research project Political Cultures, Mobilisation and Violence in Spain, 1930–1950, funded by the Spanish Ministerio de Economía y Competitividad. Some of his most recent published works are the articles ‘Il falangista “rivoluzionario”. Tre momenti nell’itinerario politico di Dionisio Ridruejo’, *Spagna Contemporanea*, 48 (2015) and ‘Los falangistas de Escorial y el combate por la hegemonía cultural y política en la España de la posguerra’, *Ayer. Revista de Historia Contemporánea*, 92 (2013), as well as a collection edited together with Javier Rodrigo Sánchez, *Tierras de nadie. La Primera Guerra Mundial y sus consecuencias* (Granada: Comares, 2014).

Jill E. Twark is Associate Professor of German at East Carolina University. Her research focuses on recent German literature and culture, particularly how authors and artists respond to major upheavals like German reunification or financial crises. She has published widely on humour and satire in post-unification German literature. Her monograph, *Humor, Satire, and Identity: Eastern German Literature in the 1990s* (2007), was followed by two edited volumes, *Strategies of Humor in Post-Unification German Literature, Film, and Other Media* (2011) and *Envisioning Social Justice in Contemporary German Culture* (2015). On the topic of representations of the Nazi past in contemporary German culture, she has published an article on Günter Grass's 2002 novella *Im Krebsgang*, and a co-authored article on Jan Ole Gerster's 2012 film *Oh Boy (A Coffee in Berlin)* is currently under review. She is now working on assessing German-language literary and filmic reactions to global, local and personal financial crises.

NOTES FOR CONTRIBUTORS

Contemporary European History covers the history of eastern and western Europe, including the United Kingdom, from 1918 to the present. By combining a wide geographical compass with a relatively short time span, the journal achieves both range and depth. It is open to all forms of historical enquiry – including cultural, economic, international, political and social approaches – and welcomes comparative and transnational analysis.

Submissions

Authors wishing to submit articles for publication should do so through the journal's online submissions system at <http://mc.manuscriptcentral.com/conteurohistory>.

Articles should normally be about 8,000 words long, the total to include footnotes. Review articles should not exceed 5,000 words.

The journal is published in English, and contributions are normally submitted in that language; however, we will also consider articles submitted in other major European languages. If accepted for publication, these will be translated. All articles, including those commissioned, will be refereed.

An abstract of each article is published in English, French and German.

Submission of a paper will be taken to imply that it is unpublished and is not being considered for publication elsewhere. On acceptance of a paper, the author will be asked to assign copyright (on certain conditions) to Cambridge University Press. An article cannot be published unless a signed copyright form is returned promptly.

Contributors are responsible for obtaining permission to reproduce any material in which they do not hold copyright and for ensuring that the appropriate acknowledgements are included in their text.

The editors would be grateful if contributors kept closely to the journal's stylistic conventions. Copy-editing is time-consuming and the editors will return any contribution which does not follow the conventions for correction and re-typing.

Contributors of accepted papers will be expected to submit a final version which should include

1. the text, which should begin with the title, the author's name and email and postal address, and the author's affiliation as he/she should wish it to appear
2. a 100-word summary of the article in English, French or German
3. a short title for use as a running page-head
4. a statement of the article's length in number of words (including both text and footnotes), and a list of tables, graphs, maps and any other illustrative material (each of which should be supplied as a separate file)
5. a short biographical note with a description of work in progress and previously published work (130 words max.)
