Editorial Policy

Central European History publishes articles, review articles, book reviews, and conference reports dealing with the history of German-speaking central Europe. The journal solicits manuscripts using all approaches to history and dealing with all historical periods. Because space is limited, articles that have been or soon will be published elsewhere are not accepted. If it is learned that an article is under submission to another journal while being considered at CEH, consideration will cease immediately. Unsolicited book reviews are not accepted.
