Translated from the Nahuatl, with an Introduction and Commentary, by John Bierhorst. Since its rediscovery in the 19th century, the codex *Cantares Mexicanos* has come to be recognized as the chief source of Aztec poetry and one of the monuments of American Indian literature. Here translated in its entirety for the first time, the text is accompanied by an extensive Introduction and a detailed commentary on each of the 91 songs. The songs are presented in a paleographic text of the original Nahuatl with facing English translations. Compiled by native scribes in the late 16th century, and preserving almost all known examples of Aztec music notation, the *Cantares* reenact battles, describe the effects of the Spanish Conquest, touch on Christian subjects, and even deal with transvestite and homosexual themes. \$45.00

With an Analytic Transcription and Grammatical Notes

John Bierhorst. Based on the codex *Cantares Mexicanos*, this is essentially a companion volume to the author's translation of that work. The dictionary provides a virtually complete glossary of 16th-century Aztec poetic usage, including many definitions not found in the standard dictionaries of Molina and Siméon. Except for work in the field of poetry, where it can stand as a reference of first resort, the dictionary should be regarded as a supplement to Molina and Siméon. The concordance, together with the analytic transcription, enables one to trace each word, its cognates, and its synonyms throughout the *Cantares*. The volume also includes a skeleton grammar and a special concordance to *Cantares* vocables, or nonsense syllables. \$65.00

The Women of Mexico City, 1790-1857

Silvia Marina Arrom. This pioneering study challenges the traditional view of 19th-century Latin American women as passive, powerless beings, absorbed in familial duties, confined to the home, and totally subordinated to men. Drawing upon sources largely ignored by historians of Latin America, the author examines the lives of the women of Mexico City during the long transition from colonial rule to the Juarez period. Her findings demonstrate that if independence did not bring the promised profound changes in women's lives, it did result in significant improvements in their status under the law, in their educational opportunities, and in their position within the family. The Potosí Mita, 1573-1700 *Compulsory Indian Labor in the Andes*

Jeffrey A. Cole. Potosí was for over a century the most important source of silver in the Spanish American Empire. It owed much of its success to the mita, a system of draft Indian labor for working the mines and refineries. Assailed as a form of servitude worse than slavery and accused of depopulating the provinces subject to it, the mita was supported, however reluctantly, by many who believed that Potosí silver was essential for Spain's survival. This book traces the evolution of the mita through the end of the Hapsburg epoch, focusing on its metamorphosis under pressures of changing production at Potosí and demographic developments in the provinces. It also considers the factors that hindered the Hapsburg government's effective administration of the mita. \$29.50

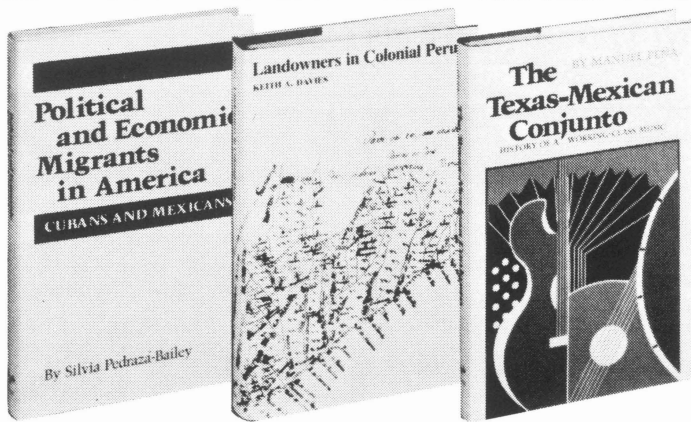

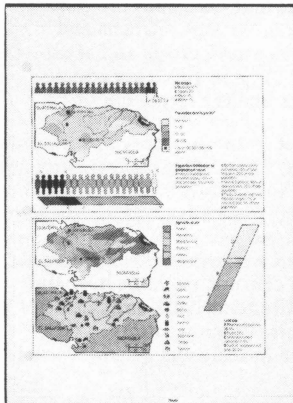

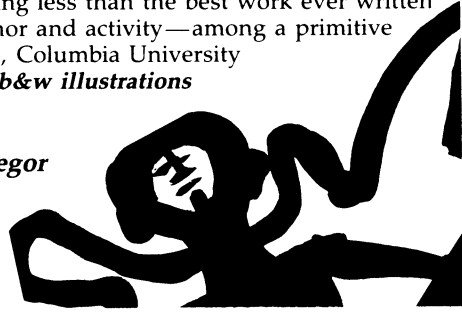
