The aim of this book is to provide an introduction and a practical guide for the use of the legislative draftsman. The need for precision and accuracy are acknowledged as axiomatic by all with legal training and experience and, as the author says, although experience and practice count for much there is ample room for guidance on legislative expression. The book does not set forth dogmatically those practices which are right and condemn contrary practices as wrong; there is often no clear-cut right and wrong way in such a practical art. However, if technique is combined with the experience and maturity of judgement of the draftsman, then higher standards of precision, elegance and simplicity may be achieved.

This book is devoted to a detailed study of the Inheritance (Family Provision) Act 1938, its operation and the procedure on claims made under it, supported by full tables of cases and statutes. The relevant provisions of the Matrimonial Causes Act 1965 are also dealt with together with the New Zealand Family Protection Act 1955. The Appendices set out these Acts, the relevant Rules, a selection of conveyancing and court forms and notes on cases. Since the Family Provision Act 1966, the county courts have been dealing regularly with applications under the Family Provision Acts. This book therefore will be of much use as a practical guide for solicitors; a valuable feature is the inclusion of details of sums awarded in unreported cases.
