CONTRIBUTORS

David Yee is Assistant Professor in the Department of History at Metropolitan State University–Denver. He received his PhD from Stony Brook University, and was a postdoctoral fellow at the University of Colorado–Boulder. He is the author of *Informal Metropolis: Land, Water, and Shelter on the Edge of Mexico City* (University of Nebraska Press, forthcoming) and is currently working on a historical panorama of global modernism in 1964, tentatively titled "Twilight of the Radiant City."

Philip Janzen is Assistant Professor in the Department of History at the University of Florida. He studies migration, race, and empire in Africa and the Atlantic World. He is working on a book manuscript about the lives and ideas of people from the Caribbean who worked for the French and British colonial administrations in West and Central Africa. Janzen received his PhD in African History from the University of Wisconsin-Madison in 2018.

Professor of History at Montclair State University (Montclair, New Jersey), James P. Woodard is the author of Brazil's Revolution in Commerce: Creating Consumer Capitalism in the American Century (2020), A Place in Politics: São Paulo, Brazil, from Seigneurial Republicanism to Regionalist Revolt (2009), and articles published in the Hispanic American Historical Review, International History Review, Journal of Latin American Studies, Journal of World History, and Luso-Brazilian Review. He has held visiting appointments in the History departments of the Universidade Estadual Paulista, the University of Maryland, and Brown University, and he is book review editor of the Hispanic American Historical Review for the 2017–22 term.

Adrian Masters is a postdoctoral fellow at the German Research Foundation's SFB-923 research group on threatened social orders at the Eberhard Karls Universität Tübingen. There, he is exploring Spanish-Chinese relations in 1600s Manila. He received his PhD from the University of Texas at Austin in 2018, and was subsequently a fellow at the Institute for Historical Studies (2018–19). His research currently explores regimes of human difference, petition-and-response statecraft, bureaucracy, and gender. His upcoming work includes *The Radical Spanish Empire*, co-authored with Jorge Cañizares-Esguerra, a monograph on petitioning tentatively entitled *We the King: Creating Royal Decrees in the Sixteenth*

Century Spanish New World, and a book on Spanish-Chinese relations in Manila (in progress). He lives between Monteverde, Costa Rica; Tübingen, Germany; and Durrës, Albania.

Daniel Gunnar Kressel is a Minerva Stiftung Fellow at the Institute for Latin American Studies at the Free University of Berlin. He is a historian of modern Latin America and the Iberian peninsula and specializes in the history of transnational right-wing ideologies and networks during the Cold War era. He also explores related issues such as neoliberalism, Catholic spiritualism, and transitions from dictatorship to democracy from an international perspective. He is completing a book manuscript with the working title "Tecnócratas: Post-Fascist Authoritarianism in Spain, Argentina, and Chile, 1946–1988," which traces the rise and fall of the Opus Dei's technocratic-authoritarian state model of the 1960s.

Richard Salvucci is Professor of Economics at Trinity University. His most recent publication is (with Linda K. Salvucci) "The Lizardi Brothers: A Mexican Family Business and the Expansion of New Orleans, 1825–1846," Journal of Southern History 82:4 (November 2016): 759–788. He is writing on the Lizardi and on the economic history of Mexico.
