# Volume I: The Origins of the United States Court of Military Appeals, 1775–1950 Jonathan Lurie

Why must military justice be different from civilian justice? How different should it be? And to what extent should it be influenced or administered by civilian participants? These are the broad topics addressed by Jonathan Lurie's comprehensive history of the development of appellate review of military justice in the United States.

Predating federal district courts by more than a decade, the courts-martial established by the Continental Congress in 1776 were among the first tribunals authorized by the United States. Lurie tells the story of how Congress finally created a civilian appellate court, the Court of Military Appeals, to sit at the top of this military justice system. Why it chose to do so in 1950, with the enactment of the Uniform Code of Military Justice, rather than at an earlier date, is a central theme of his book.

# A Rebuttal to Daniel Callahan's Proposal to Limit Health Care for the Elderly

Robert L. Barry, O.P., and Gerard V. Bradley With a prologue by Nat Hentoff

Can we put a price tag on life without devaluing it? Can we decide for someone else that life isn't always good and death isn't always bad? Should life be judged only by its "quality"? Are the elderly worth the cost of their own health care?

These and other tough questions are raised in *Set No Limits*, which cogently challenges age-based rationing schemes of the type proposed by Daniel Callahan in his highly publicized book *Setting Limits*. The founder and director of the Hastings Center, the nation's leading bioethics center and an institution whose policies often have been accepted as doctrine by the American Medical Association, Callahan has asserted that all medical care and treatment should be denied the elderly when they reach the end of their "natural life span," somewhere around—even before—80 years of age.

Set No Limits charges that such rationing would be unjust and profoundly biased. The contributors criticize the proposal from legal, economic, philosophical, medical, and religious perspectives. Theirs is a thorough and unflinching critique of a concept that could become standard medical practice, as the U.S. health care establishment attempts to deal with ever increasing medical expenses.
