In 'The Mask and the Face: The Perception of Physiognomic Likeness in Life and Art,' E. H. Gombrich raises the question of how we recognize likeness—of facial expression, of a portrait or caricature in relation to its object, or in a series of portraits of the same person.

Julian Hochberg rejects the theory of empathy as well as traditional empiricist and more recent Gestaltist theories. He suggests instead that the expectancies aroused in the scanning processes of visual perception account for recognition of likeness. The book concludes with an essay by Max Black 'How Do Pictures Represent?' He shows that no criteria for defining conditions of representation have been established and concludes that representation is a cluster concept.

Nietzsche's Thought of Eternal Return

Joan Stambaugh

Nietzsche's own statements on eternal return are insolubly contradictory, and they cannot even be reconciled in light of Nietzsche's standing within the traditional metaphysical dualism of subject-object prevalent since Descartes. Thus, after presenting the various theories of eternal return in Nietzsche's writings, Joan Stambaugh explores the extent to which Nietzsche was influenced by the idea of a cyclical time dominant in Greek philosophy and by the idea of rebirth present in Eastern thought. This leads ultimately to the suggestion of a new theory of time and to a rethinking of the relation of time and eternity.
