# RUSSELL on CRIME

This is the standard treatise on the English criminal law. Since 1819, when *Russell on Crime* was first published, it has grown to be a major classic. Its task has always been to provide a proper comprehension of the principles of the law relating to indictable offences. In this twelfth edition Mr. J. W. C. Turner has continued his work of bringing *Russell* up to date with the latest developments in the criminal law.

Such important new cases as *Welham v. D.P.P.* [1961] A.C. 103; *Sykes v. D.P.P.* [1962] A.C. 528; *Shaw v. D.P.P.* [1962] A.C. 220; and *Fisher v. Raven* [1963] 2 W.L.R. 1137 have all required treatment in this edition. Doubts expressed previously about the Homicide Act, 1957, have been realised and further consideration has been given to this Act and the cases stemming from it.

New statutes which have been dealt with include the Mental Health Act, 1959, the Road Traffic Act, 1960, the Suicide Act, 1961 and the Betting, Gaming and Lotteries Act, 1963
