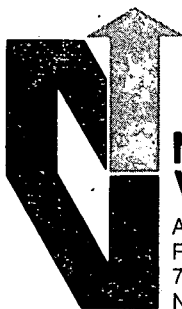

## A WORLD OF INFLATION

GEOFFREY MAYNARD and W. VAN RYCKEGHAM

Applying econometric data to structural questions, this account of inflation in the Western capitalist world since the end of World War II examines fluctuations in the average employment rate, productivity growth, disequilibria in the balance of trade, and other critical factors to explain why some countries have fared better than others in economic crunches, and some, like Japan and Italy from 1950-1960 have acted as brakes on world inflation. A separate chapter is devoted to the acceleration of world inflation since 1968. 1975. 250 pages. \$20.00

## STUDIES IN THE RUSSIAN ECONOMY BEFORE 1914

OLGA CRISP

In this landmark interpretation of the economy of pre-revolutionary Russia, the author attacks certain orthodoxies, still extant, begun by Soviet historians who used economic data as ammunition against a Tsarist government. This book shifts the emphasis away from their preoccupation with politics, back toward an examination of how pre-1914 forces actually operated and how they interacted with government policies.

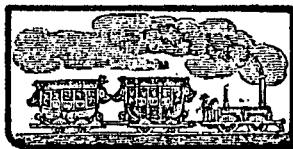

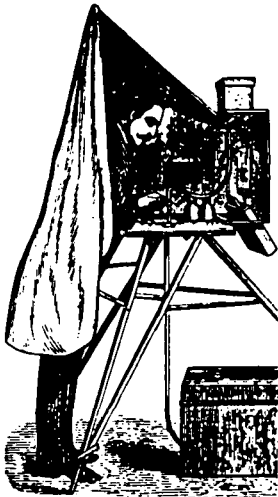
