

So that, whatever value the book may have in other respects, as a contribution to the solution of an important otological problem, it does not, unfortunately, carry us very far, and the mists of prejudice and ignorance that have clung about this method of treatment for so long a time still remain as dense as ever.

### NOTES AND QUERIES.

At a meeting of the Glasgow University Court, held on December 12, 1913, Dr. John Macintyre was appointed a University Lecturer on Diseases of the Nose and Throat, and Dr. J. Kerr Love was appointed a University Lecturer on Diseases of the Ear.

Mr. Harold L. Whale, London, has been appointed Surgeon for Diseases of the Ear, Throat and Nose to the Hampstead General and North-West London Hospital.

We are interested to observe that what seems to be a new and commendable departure has been taken by the Western Ophthalmic Hospital, London, in appointing a Surgeon for Diseases of the Throat, Nose and Ear to the Institution.

Mr. Harold A. Kisch has been appointed to the post.

#### RADIUM IN DEAFNESS.

Dr. Walker Wood writes: "In the JOURNAL OF LARYNGOLOGY, RHINOLOGY AND OTOTOLOGY of January, 1914, in 'Notes and Queries,' there is a question by 'Retzius' as to the value of radium in the treatment of deafness. I have seen and examined many cases treated by the ultra X rays (which are practically the same as those utilised in radium treatment), and the results in my opinion are unsatisfactory. The improvement, such as it was in four cases shown at the British Oto-Laryngological Society in July last, might quite easily be explained by improvement in general health or be simple variations in hearing. Also such an improvement is obtainable in other ways than by radium."

Dr. Max Halle (Berlin) also writes: "A few days ago there was a meeting of the Otological Society, at which various reports were made from different quarters on experiments with radium, mesothorium, and with the latest *réclame*, diathermy. It came as no surprise to any person of intelligence that the reports were unanimously negative. Not a single observer had seen any result, apart from the subjective sensations of the patients. All objective experiments were absolutely negative!"

## CLINICAL INSTRUCTION.

**A Clinical Demonstration** on the Diagnosis and Treatment of Selected Cases (Larynx, Nose, Ear) will be given each Monday at 5.30 p.m.

**A Course in Surgical Anatomy and Physiology** will be given each Thursday at 5.30 p.m. These Courses are free to Students of the Hospital. Others a fee of 2 guineas for each Course.

**Practical Instruction** in the Diagnosis and Treatment is given **daily** in the Out-patient Department from 2 to 5 p.m., on Tuesdays and Fridays from 6.30 p.m. to 9 p.m., and Mondays at 9.30 a.m.

**Major Operations** are performed at 10 a.m. on Tuesday, Wednesday, Thursday, Friday, and Saturday, and Fridays at 2 p.m.

**Minor Operations** daily (Mondays excepted) at 9.30 a.m.

**Operative Surgery Classes** can be formed at any time on application.

Practice in **Direct Laryngoscopy, Tracheoscopy, Bronchoscopy,** and **Œsophagoscopy** will be given to Students, to enable them to become familiar with the use and manipulation of the instruments.

Practitioners and Medical Students are admitted to the Practice of the Hospital at a fee of five guineas for three months, eight guineas for six months, or ten guineas for a Perpetual Studentship. Each course may commence at any date. Special terms to men in actual practice who can only attend the hospital once or twice a week.

The Hospital contains 48 beds for In-patients. There is also an Out-patient attendance of nearly 50,000 yearly.

Gentlemen may enter to the practice of **The Throat Hospital** at any time, and on certain conditions eligible for appointment as **Clinical Assistants**, whose duty it is to Assist the Member of the Staff to whom they are appointed.

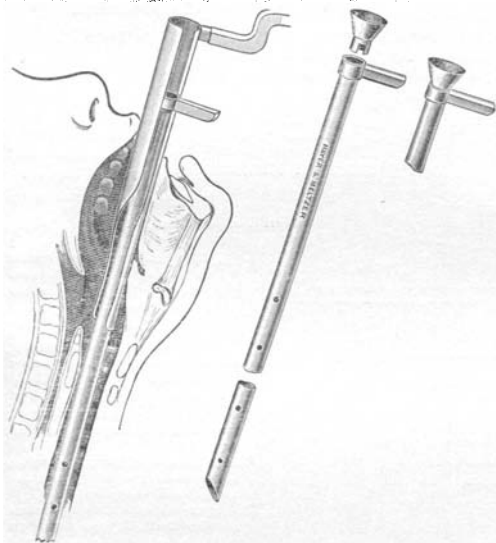

## Instrument to Facilitate Per-Oral Bronchoscopy.

Devised by WILLIAM HILL, M.D., and shown at the May Meeting of the Laryngological Section of the Royal Society of Medicine.



The lateral slot not only permits of binocular vision and easy instrumentation when operating on the larynx, but it also facilitates the rapid passage of a tracheoscope or bronchoscope in cases where (1) there is dyspnoea from spasm, etc., during operations on the larynx, more especially in children; (2) for *per-oral* tracheobronchoscopic explorations where there is difficulty or delay in finding the contracted laryngeal vestibule, more especially when working with a narrow bronchoscope alone in children; (3) to relieve at once, without resorting to tracheotomy, the temporary spasmodic dyspnoea which sometimes supervenes on administering an anæsthetic in cases of laryngeal and tracheal obstruction.
