

"Richard Swedberg's biography of Joseph Schumpeter (1883-1950) thoughtfully uncovers different layers of the eminent economist's personality. There was Schumpeter the haughty Austrian, fond of women and champagne, who went into debt to rent a castle and keep a riding stable. (The year was 1919; Austria was gripped by postwar inflation; Schumpeter was finance minister. The Government caught him in an intrigue and fired him.) There was Schumpeter the Viennese neurotic, who prayed to the ghosts of his dead wife and mother, who may have killed himself with overwork and who scribbled down savage, funny aphorisms. But the most important Schumpeter was the learned, perceptive, eloquent thinker who shaped our modern understanding of economics. 


