CONTRIBUTORS

Jennifer Bain is Professor of Music at Dalhousie University and was recently named to the Royal Society of Canada's College of New Scholars, Artists, and Scientists. Her articles have appeared in numerous music journals and book collections, and she is editor of a special early music issue of the *Journal of Music Theory*, and co-editor with French literature scholar Deborah McGrady of *A Companion to Guillaume de Machaut* (Brill, 2012). Currently co-investigator on Cantus Ultimus, a project that builds on the digital infrastructure of the Cantus Database to develop tools for the machine-reading of plainchant manuscripts, her book, *Hildegard of Bingen and Musical Reception: The Modern Revival of a Medieval Composer*, was published by Cambridge University Press in 2015.

Charles E. Brewer is Professor of Musicology in the College of Music at Florida State University. His research has encompassed the medieval music of East Central Europe, medieval song, seventeenth-century instrumental music and the music of William Billings.

Karin Strinnholm Lagergren is Senior Lecturer in musicology at the Linnaeus University in Sweden and a Research Associate at Alamire Foundation, Leuven University. Her research focuses on Gregorian Chant, particularly the chant of medieval Scandinavia and in the Order of the Birgittines. From 2017 to 2020 she will be conducting the three-year research project 'The Musical World of the Birgittine Order – A Comparative Study of Four Birgittine Abbeys' under the sponsorship of the Swedish Foundation for Humanities and Social Sciences.
