Update on Comment Period for OSHA's TB Standard

The comment period for the OSHA proposed rule on occupational exposure to tuberculosis (published in the *Federal Register* on October 17, 1997) has been extended by 60 days. The new deadline for written comments and notices of intent to appear at a public hearing is February 17, 1998; the deadline for written testimo-

ny and documentary evidence is February 27, 1998.

The public hearings are planned to begin in Washington, DC, on April 7, 1998. Subsequent hearings in May and June likely will be in Los Angeles, Chicago, and New York City.

As mentioned in the December 1997 SHEA News, Dr. Michael Tapper,

Chair of SHEA's AIDS/TB Committee, is preparing a SHEA response to OSHA on the proposed standard. He can be reached by e-mail, mtapperd@aol.com, or fax, 212-434-2574. The number of individual responses on issues, such as the need for yearly fittesting, is believed to influence the OSHA decision-making process.
