Presidential Priorities

WC are now more than four months into the year probably six months by the time this message is published It is time for me to outline my priorities for my term as president:

- I. We wilt continue to develop new educational forums in which our members and others interested in hospital epidemiology might participate. The purpose of these programs wilt be to communicate new ideas discuss controversial issues, and provide, guidance for the practice of hospital epidemiology
 - a. A training course, co-sponsored by SHEA and the Centers I&-Disease Control (CDC), will be inaugurated this year (see notice below). This course is &signed to provide new chairpersons of infection control committees and infectious disease fellows with the fundamentals of hospital epidemiology and an approach to infectIon control. We anticipate that this program will be an annual offering.
 - b. We have now finalized plans for a two and one-half clay international conference on controversial issues in hospital epidemiology. This conference wilt he cosponsored by SHEA and InfectionControl and Hospital Epidemiology. It wilt be held in Baltimore, Maryland on March 10, 11, and 12, 1989 and will feature

- theme days on AIDS, the expanded role of hospital epidemiology, and infection control.
- c. SHEA will continue to support selected local and regional programs in hospital epidemiology. We will work with the Infectious Diseases Society of America (IDSA) to provide epidemiologic expertise in their educational undertakings.
- d. We will also maintain 'involvement in international efforts to improve infection control worldwide.
- 2. SHEA will provide expertise and leadership in developing policies on issues that address the concerns of hospital epidemiology.
 - a. Members will represent the Society and work with organiza-

- tions such as the CDC, IDSA, the American Hospital Association, the Joint Commission on Accreditation of Healthcare Organizations, the Association for Practitioners in Infection Control AAP, and SIS to define solutions for epidemiologic problems
- b. We have recharged the SHEA/APIC AIDS Task Force to be proactive in providing epidemiologic leadership on issues relating to this disease. For example, we participated in the recent CDC meeting to reassess guidelines for universal precautions.
- c. The Severity of Illness Working
 Group will maintain a close
 working relation with the Joint
 Commission as they develop

severity modifiers to diagnosticrelated groups and begin clinical studies to measure the quality of patient care. (Look for an article in the July issue of the journal, by **the** Severity of Illness Working Group describing case-mix adjusters.)

- 3. We will continue our efforts to enroll **as** many members into SHEA as possible, given our eligibility requirements.
 - a. We will provide our members with the journal, educational programs, peer support, and other appropriate forums to attract their continued involvement in the Society.
 - b. We will encourage new members from the ranks of infectious disease fellows and chairpersons of infection control committees to join SHEA, receive our journal, and participate itt our educational offerings.
- 4. We will attempt to improve the financial base and stability of the Society.
 - a. We will evaluate the impact of our present dues structure and journal affiliation on membership enrollment and revenues.
 - b. We will develop educational programs, such as the international conference, which have tltr potential to generate revenue for the Society.
 - c. We will consider the pros and cons of soliciting grant support from industry for selected societal projects.
- 5. Finally, we will begin to prepare for the future Past, present, and future presidents of the Society will tteet to delineate priorities and list specific goals for the next five years.

Joint Commission Revising Infection Control Standards

The Joint Commission is in the process of revising the "Infection Control" chapter of the Accreditation Manual for Hospitals. An advisory group of experts on infection control, including representatives from SHEA, is reviewing and critiquing drafts of the revised standards developed by the Joint Commission staff. The product of this developmental process will be submitted for field review by 3000 to 5000 individuals and organizations.
