## STATEMENT OF THE EDITOR IN CHIEF

For several years the steadily increasing costs of publishing this Journal have been absorbed by the Association in an effort to maintain its subscription rate and membership costs at the existing level. Early last year, however, the impossibility of continuing to do so, and yet to produce a journal of approximately the same quality, became irresistably patent. In conformance with the Association's Constitution permission to raise rates was sought from the membership in a referendum. The membership voted overwhelmingly in favor of the raise and, accordingly, the present volume goes out at a somewhat higher cost to its readers.

It is hoped that the increase of 25¢ per issue, the minimum raise feasible in the circumstances, will meet foreseeable advances in publishing costs and that no further raise in prices will be required.

Members and friends of the Association may assist the Journal in its continuing attempts to operate economically by paying dues or subscription fees promptly.
