Judge Rules Security Council's Tape Cannot Be Destroyed

On September 15 the U.S. District Court ruled on the lawsuit filed on January 18 by plaintiffs—National Security Archive, the American Civil Liberties Union, the American Library Association, and the American Historical Association-versus defendants-President Reagan, President Bush, and the National Security Council, and the U.S. Archivist. The plaintiffs sought to prevent the destruction of electronic messages contained on the tapes used in the Professional Office System (PROFS) used by the National Security Council staff. Many of the messages retrieved from this system played an important role in the investigations of the Iran-Contra affair. The defendants argued that most of the PROFS messages are similar to telephone messages and should not be preserved and that procedures are in place to insure that messages of enduring value are printed and filed. Although the defendants sought dismissal of the case, Judge Charles R. Richey ruled that the case should not be dismissed and that private citizens can take the President of the United States to court to challenge the White House decision to destroy the PROFS computer tapes. "Under the Presidential Records Act," Judge Richey wrote, "the President simply may not, for political reasons incident to the performance of his duties, decide not to retain documents that otherwise qualify as Presidential records." Richey expanded on this point by stressing that "the President's unilateral decision to 'flush' the PROFS system would appear to be an exercise of discretion that violates the Presidential Records Act's disposal provisions."

Statistical Data Base on CD-ROM Announced

Researchers can now have immediate access to the over 2 million pages of statistics generated annually in the U.S. and throughout the world with Statistical Masterfile, a new CD-ROM database from Congressional Information Service (CIS).

Statistical Masterfile brings together CIS's three statistical abstract and index services: American Statistics Index, unlocking statistics published by federal government agencies; Statistical Reference Index, providing access to information published by more than 1,000 American sources other than the U.S. govern-

ment; and *Index to International* Statistics, covering statistics generated by almost 100 international intergovernmental organizations.

The indexes and abstracts give researchers the ability to quickly locate hard data on population, business and financial activities, domestic and international trade, the environment, government programs, health, and many other economic, demographic, and social indicators.

Data Base on Latin America Established

INFO-SOUTH is a new information system on Latin America, which has been established at the University of Miami.

INFO-SOUTH is designed to provide access for government, business and academic users to a broad range of information on contemporary economic, political and social issues concerning Latin America. Its core is a computerized database containing bibliographic citations and abstracts of articles appearing since January 1988 in academic journals and since June 1988 in news and opinion magazines and newspaper articles. The abstracts are in English, but the material is drawn from primary sources in Spanish, Portuguese, French and Creole, as well as from U.S. and other English language sources. The citations and abstracts can be accessed online by any standard computer system; originals of all documents are maintained at the University and copies can be provided by facsimile, express or regular mail service.

The annual subscription for INFO-SOUTH is \$800. This subscription includes unlimited online access and four issues of the *Journal of Interamerican Studies and World Affairs*, published by the Institute of Interamerican Studies. The INFO-SOUTH staff will also be available to assist you in using the database and in facilitating consultation with our faculty on questions or projects concerning Latin America. There is

an additional small charge for delivery of full text documents or special searches by the INFO-SOUTH staff.
